Payment Terms and Conditions:

Registration Fee R3000-00

This is payable once the learner has been notified of his/her acceptance to Bizweni Primary School. It is non-refundable and is a once-off fee applicable to children enrolling in Grade 1 through to Grade 7 prior to commencing at the school.

Tuition Fees

- Tuition fees are payable in advance before or on the third day of every month for a period of twelve months, being January to December. (First payment due by 3 January)
- The school may charge for the late payment of fees. Overdue fees will result in additional charges at 2% per month. The School reserves the right to ask a learner whose monthly fees are not paid before or on the date to leave the school until such fees have been paid. Any work missed by the learner during this period is the responsibility of the parent.
- PLEASE ENSURE THAT PROOF OF PAYMENT IS E-MAILED TO THE SCHOOL FOR REFERENCE PURPOSES. USE accounts@bizweniprimaryschool.co.za.
- Please use the allocated account number as reference. Failure to use the correct reference will result in a penalty fee of R300-00 being charged for each failure to do so.
- Invoices will be e-mailed on a monthly basis where such information has been provided to the school.
- All other incidental charges, including music lessons, learning support, sport and aftercare will be extra and become due & payable monthly.
- Please note that parents are responsible for all monies to be paid to the school, regardless of whether the child is sponsored by a company or Trust

Sibling Discounts

Second and subsequent siblings enrolling in Bizweni Primary will receive a fee reduction of 10% of the tuition fees payable for these children's tuition. This reduction is not applicable to the 1st child.

Term or Annual Payment

- You can pay for the term in advance and qualify for a 5% discount on tuition fee only. Term fees are due by the 1st day of a Term. Term fees are calculated as 4 terms x 3 Months. The table above is indicative of a 3-month term.

- You can pay for the year in advance and qualify for a 5% discount on tuition fee only. Annual fees are due by the 1st day of Term 1

A minimum of one full month's notice in writing must be given before leaving the school. Failure to do so will result in the following month's fees becoming due and payable. No partial refunds for a month will be entertained. Refunds for term and annual payments will be treated on merit.
